Registration and information obligations concerning REACH and RoHS in the European Union and the Declaration according Conflict Minerals to Dodd-Frank Act.

As a Swiss exporter, Alu Menziken Extrusion AG can not register any substances within the meaning of the REACH Regulation (EG) 1907/2006 and (EU) 2018/2005 and their candidate list (SVHC). The responsibility lies with the European importer.

In order to ensure a high level of delivery reliability for our customers, we are intensively pursuing the implementation of REACH and the resulting requirements. Alu Menziken Extrusion AG is a pure build-to-print supplier. With the applicable standards, all REACH and RoHS requirements are fulfilled in the currently valid version. This procedure allows customers who purchase extruded aluminum products, machined parts, assemblies or other services from Alu Menziken Extrusion AG to be classified as "downstream users" according to the REACH regulation. For coated aluminum components clarification is required and we ask our customers to provide the requirements as an applicable specification at the time of inquiry. As a "downstream user", your company is fundamentally not subject to any registration obligations under the REACH regulation.

With regard to the obligation to inform about substances in products according to art. 33 of the REACH regulation, we assume that the proportion of substances of very high concern according to the "candidate list" (Annex XIV of the REACH Regulation) in our products does not exceed the limit by mass.

The declaration of conformity also applies to all currently effective substance restrictions of RoHS according to EU Directive 2011/65/EU and 2015/863/EU. Declaration of Alu Menziken Extrusion AG for handling "Conflict Minerals" Dodd–Frank Wall Street Reform and Consumer Protection Act ("Dodd-Frank Act"), Section 1502.

Alu Menziken Extrusion AG supports all efforts to prohibit the illegal trade with conflict minerals. For this we refer to section 1502 of the "Dodd-Frank Act". Its intention is that raw materials like tin, tungsten, tantalum or gold should not be sourced from the conflict regions in and around the Democratic Republic of Congo, thereby withdrawing the financial basis for wars and conflicts in these regions.

Alu Menziken Extrusion AG cooperates only with suppliers who source their raw materials or materials in an ethical manner. Based on the restrictions for using "Conflict Minerals", we expect from our supplier's transparency and open communication regarding source and procurement of their materials.

Therefore, we declare that all the components manufactured and delivered by Alu Menziken Extrusion AG have to be seen as "DRC conflict free" until further notice.
